### People-C19-EU study - Jan Maláska & Jos Latour

The aim of this survey is to provide an overview of how palliative care is delivered in European ICUs and what the impact is on moral distress of ICU staff after the era of COVID-19. The focus is on identifying factors leading to moral distress associated with providing palliative care in European ICUs.

#### Ethical practice score EPS - Spyros Mentzelopoulos

The study has now been published in Critical Care.

### EoL care and treatment limitation decisions in ICU - Victoria Metaxa & Spyros Mentzelopoulos

This is part of the Horizon grant: Enhancing palliative care in ICU (EPIC). It consists of a survey to assess feasibility and effectiveness of tele-palliative care consultations in ICU. It aims to obtain detailed information about European ICU clinicians' awareness of palliative care in ICU, and to explore the legal framework which underpins end-of-life decisions for adult patients unable to participate in decision-making.

Palliative care provision for patients with haematological malignancies -Victoria Metaxa This prospective study aims to describe the number and type of invasive interventions delivered to patients with cancer in ICU, within 24 hours of their death, to describe the type of palliative care interventions delivered to patients with cancer in ICU, within 24 hours of their death, and to evaluate the involvement of a specialist palliative care team with the above patients.

### Residents and Fellows in ICU ETH Survey: ReFInES Study - Emilio Rodriguez-Ruiz & Jos Latour

The objective of this survey is to explore the perceptions of European residents and fellows in Intensive Care Medicine of ethical challenges in their current and future practice; to define how ethical dilemmas are addressed during their training; to identify what can be improved in their training.

#### Feedback Masterclass 2023 - Carole Boulanger & Andrej Michalsen

The 4<sup>th</sup> edition of the Masterclass was on May 11/12, 2023. It is an E-Learning Course, now called "Clinical Ethics and End-of-Life Care" It was directed by Carole Boulanger and Andrej Michalsen. Faculty included Benbenishty, Efstathiou, Gerritsen, Latour, Metaxa, Milliken, Rusinová, Saha, Vergano. There were 23 participants from 13 countries, mostly nurses and physicians, with various degrees of knowledge and experience regarding clinical ethics. Evaluations were excellent. The next course will be on November 7 and 8, 2024.

ESICM End-of-Life and Palliative Care Guideline – Jozef Kesecioglu, Katerina Rusinová,

Work has been going on for a year by now. There are 7 domain groups, each with a domain chair. Literature search has largely been done by now; the next steps are to grade the literature and making the recommendations. The group aims to submit the manuscript in April 2024.

### Take-home message

Religious beliefs and practices can influence end-of-life decisionmaking. However, changes in end-of-life practices observed over 16 years appear unrelated to religious affiliations of patients or their treating physicians. Shorter time until decision in intensive care units and increased numbers of discussions with patients and their families may indicate increased awareness of the importance of end-of-life decision-making in intensive care. 
# Exploratory Analyses Conclusions

Comparison study-derived weighted/rescaled (W/R) EPS: validated as explanatory variable of treatment limitation decisions using the worldwide Ethicus study dataset.

➢Aiming at maximization of W/R EPS may increase treatment limitation frequency and limit failed cardiopulmonary resuscitation.

W/R EPS maximization is based on the combined presence of end-of-life
 ICU protocols, palliative care consultations, and national end-of-life legislation.
 Further prospective EPS validation is planned in the context of the EPIC project.

**4.4** EoL care and treatment limitation decisions in ICU - Victoria Metaxa & Spyros Mentzelopoulos

- Part of the Horizon grant: Enhancing palliative care in ICU (EPIC)
- A multicenter trial to assess feasibility and effectiveness of telepalliative care consultations in ICU
- Aims:
  - to obtain detailed information about European ICU clinicians' awareness of palliative care in ICU
  - to explore the legal framework which underpins end-of-life decisions for adult patients unable to participate in decision-making
- To be distributed in January 2024

**4.5** Palliative care provision for patients with haematological malignancies -Victoria Metaxa

- cancer care continues to be highly intensive even towards the end of life
- Aims:
- To describe the number and type of invasive interventions delivered to patients with cancer in ICU, within 24 hours of their death
- 2) To describe the type of palliative care interventions delivered to patients with cancer in ICU, within 24 hours of their death
- 3) To evaluate the involvement of a specialist palliative care team with the above patients
- Prospective, 1 -year

# **4.6** Residents and Fellows In icu Ethics Survey: ReFInES Study - Emilio Rodriguez-Ruiz & Jos Latour

**Rationale:** Intensive care unit (ICU) physicians face many ethical challenging situations in their daily practice. Including ethics training in ICU residency and fellowship is therefore recommended.

**Objectives:** To explore the perceptions of European residents and fellows in Intensive Care Medicine of ethical challenges in their current and future practice; to define how ethical dilemmas are addressed during their training; to identify what can be improved in their training.

Design: Survey study.

**Population:** European residents and fellows working in the ICU.

**Main study parameters/endpoints:** Insight in what ethical dilemmas residents and fellows working in the ICU face in their daily practice and how their ethics training during residency/fellowship can be improved to meet their needs.








