## Details on your candidature

I am an intensivist and anaesthesiologist and I am doing my clinical and scientific work in the field of intensive care medicine since 1998. After my residency in Italy, I spent 4 years in France for a clinical and research fellowship under the supervision of Prof. Laurent Brochard and I obtained my PhD in Respiratory Pathophysiology in 2003. Since 2002, I worked as a senior physician in the medical ICU of the A. Gemelli University Hospital of Rome, Italy (Director: Prof. Massimo Antonelli), where I was appointed as an Assistant Professor in 2006. In 2015, I moved from Rome to the G. d'Annunzio University of Chieti, Italy, where I was appointed as an Associate Professor and, in 2018, as a Full Professor in Anaesthesiology and Intensive Care Medicine. Since 2015, I was the Chair of the General ICU of the SS. Annunziata Hospital of Chieti, Italy, then the Deputy Chair of the Department of Anaesthesiology and Intensive Care Medicine at the same hospital and, since 2020, the Chair of the Department. I am also the Director of the Residency Program in Anaesthesiology and Intensive Care Medicine at the University of Chieti and, since 2022, the President of the national College of the Professors in Anaesthesiology and Intensive Care Medicine.

I have conducted clinical research in the field of mechanical ventilation and acute respiratory failure, and participated in several multicentre trials, co-authoring approximately 130 papers in peer-reviewed journals, including Intensive Care Medicine, Lancet Respiratory Medicine, American Journal of Respiratory and Critical Care Medicine, Critical Care Medicine, and JAMA. I authored more than 30 book chapters and delivered more than 300 lectures at National/International meetings in Europe, America, and Asia. I am a reviewer of several leading journals in intensive care medicine, and I was a Deputy Editor of "Intensive Care Medicine" journal.

I have participated in the organization of several scientific meetings at the National level, as the Director of the Organizing Committee and the Director or a member of the Scientific Committee (several meetings on ARDS, on mechanical ventilation, and on non-invasive respiratory support of the Italian Society of Anaesthesiology and Intensive Care Medicine-SIAARTI, an annual meeting of SIAARTI, and other regional meetings).

ESICM is our Society and my Society since more than 20 years. I strongly believe that ESICM is the living community of intensivists around the globe, and its annual congress is the beating heart of this community for the final aim of improving patients' care. The Society's scientific events, firstly the annual congress, are all excellent events which are appreciated worldwide. I would do my best to maintain and further develop the quality of these events to make them even more attractive. In my mind, this requires enthusiasm, creativity, clinical and research experience, and ability to teamworking, together with equity, inclusivity, and sustainability. I believe I have these qualities, as I demonstrated all along my professional career. If deemed a suitable candidate, it would be a big honor for me to serve again the Society in this important role.
