MRCP, Royal College of Physicians of London, UK (2011) enhanced my competence in internal medicine. ABIM and FRCPC in Internal Medicine and Critical Care (2012–2017, USA & Canada) solidified my expertise through rigorous North American training. Fellowship in Extracorporeal Life Support and Critical Care Echocardiography, University of Toronto (2017–2019) – deepened my specialization in advanced cardiopulmonary support. Diplomate in Critical Care Echocardiography (2019, USA) and ECMO Diploma (2017, Paris, France) accredited subspecialist competencies relevant to ESICM's educational agenda. Executive Education, Harvard Medical School (2024–2025): Leading Digital Transformation in Health Care equipped me to lead innovation, a quality increasingly relevant to the Society's strategic direction.
