It is with genuine enthusiasm that I submit my application for the position of NEXT Committee Member Elect.

I am a young intensivist at Fondazione IRCCS Ca' Granda Policlinico di Milano, where I had the privilege of training in a historic center for intensive care. My mentors have instilled in me, and continue to do so, the love for pathophysiology, the importance of scientific rigor, the passion for exploring details from which new ideas arise, and the value of understanding the mechanisms underlying clinical phenomena. Since 2021, I have been serving as an attending physician in a general intensive care unit, primarily caring for patients with ARDS and those supported with ECMO, while also working in prehospital and in-hospital emergency medicine.

Research has always been an integral part of my professional identity. Since medical school, I have been involved in scientific projects, beginning as research fellow in the CENTER-TBI study. I am now Principal Investigator of studies on ECMO and ARDS, and collaborator in international multicenter trials. My work has resulted in more than 30 peer-reviewed publications, invited lectures, and several awards. Beyond formal research, I deeply enjoy discussing pathophysiology with colleagues, residents, and students, and as tutor at the University of Milan School of Anaesthesiology and Intensive Care I am engaged in structured teaching.

My motivation to apply for the position of NEXT Committee Member stems from a commitment to strengthen the bridge between clinical work and research for young intensivists. Today, many colleagues are overwhelmed by workload even before completing their training, with the risk of putting aside curiosity and scientific growth. This transition into professional life often leaves them feeling insecure or alone, sometimes hesitant to seek guidance. I believe the NEXT Committee can play a key role in supporting them, supporting all of us, by creating a network that fosters collaboration, knowledge sharing, and opportunities to generate new ideas directly from clinical practice.

As an ESICM member for several years, I have greatly valued the educational initiatives of the NEXT group, and I would like to collaborate with other NEXT Committee members to consolidate and further expand them. My goal is to ensure continuity of NEXT projects while promoting a vision in which clinical observations become research questions and research outputs translate into better care.

I see ESICM as a family, and within this family the NEXT Committee represents the younger generation, whose energy and creativity must drive innovation. In this context, I believe young intensivists should take the lead in promoting the responsible and structured use of emerging tools such as artificial intelligence, which is rapidly becoming a powerful resource for knowledge and clinical decision–making. Likewise, I consider simulation training a cornerstone for education and collaboration, and one that should be increasingly implemented.

Finally, I believe it is essential to bring research back to its roots: curiosity, scientific rigor, and the sharing of knowledge in a way that is both accessible and robust.

As a NEXT Committee Member, I hope to propose and champion these new approaches, always under the guidance of the more experienced members of the ESICM family. I would like to contribute to a NEXT Committee that is a true community, providing mentorship, resources, and collaboration, and ensuring that every member feels supported and connected.
