I have also participated as a faculty member in ESCIM workshop for EDIC preparation.

I have been serving as an EDIC II examiner since June 2017 in the centers of Stuttgart and Vienna which has been a great educational experience for me so far and I am always impressed by the organization ,the format and the content of the exam that targets to a high level of verification in intensivists across Europe and other parts of the world. I am currently finishing on October 2025 my second term of office in EDIC Sub-comittee. I have organised and established on May 2025 the first EDIC exam center in Greece in Chania ,Crete with the help of EDIC Sub-Comittee and ESCIM Office in Brussels.
