I am an intensivist-internist working as an attending physician in the 1st ICU of the General Hospital of Thessaloniki "G. Papanikolaou" in Thessaloniki, Greece. I hold an MSc in Medical Research Methodology and was awarded the title of Intensivist in July 2024.
