Details on your candidature

I am eager to put forward my candidacy for the role of a NEXT committee member. I would greatly value the opportunity to work within the ESICM NEXT community, contribute to the broader ESICM structure, and enhance the participation of young ICU professionals within ESICM.

I am a Specialty Registrar (senior resident) in Anaesthesia and Intensive Care Medicine at Addenbrooke's Hospital in Cambridge. I have recently completed a PhD focusing on the host response to acute infection at the gene expression level at the Wellcome Sanger Institute. I have been involved in ESICM in different capacities including as a member, first and co–author on poster presentations at congresses over the last 4 years, and most recently as a recipient of the NEXT research grant (2024) funding a study to undertake transcriptional profiling in a cohort of patients with acute liver failure (ALF).

I have extensive experience of serving on national and international committees, with specific experience of representing trainees and young professionals. I was elected to the International Liver Transplant Society (ILTS) Vanguard committee (members less than 42y of age) as a trainee representative for a 2-year period (2022–2024) and undertook various activities including speaking at the Vanguard debate session at the ILTS annual congress and chairing and presenting at their monthly webinars. I am currently on the ILTS Steering Committee for the acute liver failure (ALF) Special Interest Group which has given me a platform for research into ALF and an opportunity to contribute to the development of a global ALF registry. I was appointed into the role of trainee representative for the National Institute of Academic Anaesthesia through competitive selection in 2021 and have organised the 'Introduction to Academic Anaesthesia'

conference for trainee anaesthetists and intensivists for the last 3 years. This has involved invitation of high-profile speakers in the specialty, significant planning and organisation, and engagement of trainees during the events. Most recently I have served as the trainee representative for the updated Association of Anaesthetists of Great Britain and Ireland (AAGBI) Vascular Access guidelines, which enabled me to partake in the research and writing of consensus guidelines.

I hope to be able to bring the experience and collaborations I have gained through these roles into the position of NEXT committee member. I aim to encourage young professionals to undertake research activity within their clinical career and demonstrate that there are many ways to integrate the two strands through the rich network of clinical academics within ESICM. I would also advocate for young professionals to participate in the development and writing of ESICM clinical guidelines, and support them in taking on wider roles within the society. I aim to strengthen collaborations with other societies, such as ILTS, for example through joint webinars or other activities with their trainee committees to build networks of young professionals with shared interests across Europe. Supporting the exchange of ideas, and facilitating movement and exchange between countries, is key to building the networks of the future and keeping the Society vibrant.

I am dedicated to supporting young professionals as the future of critical care medicine. It would be an honour to serve ESICM as part of the NEXT committee and contribute to the active and thriving community of people interested in furthering the discipline of critical care.
