With great enthusiasm, I want to apply for a position as national representative at ESICM.

I am board-certified intensivist since 2014, and I combine my clinical work as intensivist at UZ Leuven with research and education as Professor at KU Leuven. I am also responsible for the training programme of intensivists at the department of intensive care medicine in UZ Leuven ("stagemeester", "maître de stage"). I have a particular research interest in the metabolic and endocrine mechanisms of organ failure in critical illness, and I have a broad (inter)national network.

I am ESICM member since 2015, and I am well acquainted with the society. I have contributed to many research and educational activities initiated or endorsed by ESICM. I am active member of the ESICM-FREM section, and I have represented the section in the Clinical Training Committee (2024) and in the Academic Subcommittee under the Education and Training Committee (2025). I have been co-author of the ESICM-eLearning modules on ICU nutrition, core faculty member of a 2-day online course on ICU nutrition (yearly since 2022), and tutor of 1-week fellowships on this topic in UZ Leuven (yearly since 2022). I am EDIC-II examiner since 2019 (yearly since 2021). I have been steering committee member of different research projects initiated within the ESICM-FREM section, and I have contributed to several other ESICM-endorsed studies. In 2022, ESICM granted me the Fundamental Research Award, which provided funding for a translational multicenter project. I have been scientific mentor for the Research Learning Pathway level 3 organized by the society (2023-2024). Also within Belgium, I have initiated or contributed to a considerable number of multicenter studies in both academic and nonacademic hospitals, and I am involved in the interuniversitary course in intensive care medicine for the Dutch-speaking intensivists in training. Hence, apart from being an experienced clinician, I am a clinical scientist with different active research projects in collaboration with national and international colleagues, and I have a substantial engagement in education. I have a senior clinical investigator fellowship grant by FWO and I have published more than 145 manuscripts in peer-reviewed scientific journals.

I am elected board member of the Belgian Society of Intensive Care Medicine (SIZ) since 2022. As scientific society, SIZ aims to promote education and research in intensive care

medicine, as well as knowledge exchange and collaboration between centers. Also, the society has a key role in informing policy makers, and provides advice on the organization of ICU care, with the ultimate aim of promoting sustainable qualitative care at the bedside.

If I am elected, I would be a liaison between the Belgian and European Society of Intensive Care Medicine, which would be a great advantage for both societies, as many aspects of their mission overlap.
