Details on your candidature

I am an Associate Professor of Intensive Care Medicine and currently Head of the Division of Intensive Care Medicine, Department of Internal Medicine, at Çukurova University Faculty of Medicine. My career has combined clinical leadership, academic teaching, scientific research, and active involvement in professional societies—experiences that have equipped me with the vision, skills, and international perspective required to represent Türkiye effectively within ESICM.

Within the Society of Turkish Intensivists (TUYUD), I have held leadership roles including Secretary of the 21st National Congress and the 13th Afro-Eurasia Meeting (2025), as well as Secretary of the TUYUD Ultrasound Working Group (2024-present; member 2021–2024). I also served as Course Director and Instructor of the POCUS Course at WICC 2023, and contributed internationally as Instructor of the Ultrasound Course organized in Baku under the auspices of the Turkish Cooperation and Coordination Agency (TİKA) in May 2025. These responsibilities highlight my strong commitment to advancing education and training in intensive care medicine.

Beyond TUYUD, I am a member of ESICM, ESPEN, the Turkish Society for Clinical Nutrition and Parenteral Nutrition (including its Young Academicians and Clinical Researchers Working Group), and several other national and international professional societies. I was accepted as a participant in the prestigious ESPEN T-LLL Course (2025), have completed multiple LLL modules, and have actively contributed to both national and international ultrasonography training programs. My academic contributions include peer-reviewed publications on sepsis, ultrasound, nutrition, and organ support strategies. In addition, I serve as Section Editor for Intensive Care Medicine at Scientific Reports (Nature Portfolio).

Through this candidature, I envisage my role not only as a representative but also as a bridge between ESICM and the Turkish intensive care community. My priorities will include:

- Strengthening collaboration between ESICM and Turkish intensive care societies,
- Promoting young intensivists' active involvement in international working groups and projects,
- Expanding educational opportunities in point-of-care ultrasound, sepsis management, hemodynamic monitoring, clinical nutrition, and EDIC preparation,
- Contributing to multicenter research initiatives that enhance the international collaboration and visibility of Turkish ICUs,
- Fostering innovation through digital health, artificial intelligence, and tele-ICU applications,
- Supporting practices that strengthen alignment with international guidelines and quality standards in ICUs,
- Enhancing public awareness and understanding of intensive care,
- Establishing mentorship and leadership development pathways for young intensivists.

I believe that my clinical leadership, academic expertise, international teaching experience, and editorial responsibilities position me strongly for this role. My vision is to

enhance Türkiye's contribution and visibility within ESICM while fostering mutual learning and collaboration to benefit both Turkish intensivists and the wider European intensive care community.
