I am writing to apply for the position of Chair of the Trauma and Emergency Medicine (TEM) Section of ESICM. Over the past years, I have been actively engaged in the Society, including participation in the NEXT Committee, which strengthened my contribution to the growth of young intensivists and to ESICM's future. My education combines the European Diploma in Intensive Care Medicine and a Master of Science in Disaster Medicine with a Certificate in Medical Leadership (2024), which has refined my ability to coordinate teams and projects across clinical, educational, and research domains.

Professionally, I serve as Consultant in Anesthesia and Critical Care at Humanitas Research Hospital in Milan, where I am Lead for in-hospital emergency management. My international experience includes a Trauma Critical Care Fellowship at the Royal London Hospital and a HEMS Fellowship with London's Air Ambulance, providing direct exposure to high-complexity trauma and prehospital emergency care. In addition, my fieldwork with Médecins Sans Frontières (MSF) offered invaluable hands-on experience in austere and resource-limited environments, complementing my hospital-based practice with a global and humanitarian perspective.

Academically, I have authored numerous peer-reviewed publications on trauma, emergency systems, mass-casualty management, and long-term outcomes of critically ill patients. As Adjunct Professor at Humanitas University, I contribute to training the next generation of healthcare professionals, with a focus on simulation-based learning and emergency management.

If elected, I would aim to consolidate the TEM Section as a multidisciplinary hub that bridges clinical excellence, education, and research. I envisage developing projects such as:

Expanding multicenter trauma and prehospital critical care research within ESICM.

Enhancing educational programs through simulation, case-based learning, and cross-sectional workshops with the Education & Training and e-Learning Committees.

Promoting the Section's role in disaster preparedness and mass-casualty response, leveraging international and humanitarian field experience.

Strengthening communication and inclusiveness within the Section to ensure members' contributions shape its scientific and educational agenda.

I believe my combination of clinical expertise, international and humanitarian fieldwork, leadership training, and academic engagement equips me to represent the Section effectively and foster collaboration across the ESICM community. It would be an honor to serve as TEM Section Chair.
