Details on your candidature

I am an intensivist still trying to find my place. I am currently working mostly with the East of England Adult Critical Care Transfer Service which is providing a different view of critical care and visiting institutions throughout the region.

Critical care transfers, both within and between institutions, are an essential but often neglected part of our specialty.

The need for inter-facility transfer varies depending on the degree of centralisation of healthcare systems and local factors but it is always a potential requirement and requires coordinating multiple human factors and extensive communication to avoid incidents. Internal transfers are very frequent. Although some are routine, they also apply to patients in extremis requiring investigations or interventions for their deterioration. The incidence of complications is reported as high although most of these are thankfully minor.

Still, both of these situations are complex and require preparation. ESICM provides a very useful resource in the form of three ACE modules on these topics but there is always room for more development of educational resources.

I have enjoyed a broad experience in intensive care units through Belgium and the United Kingdom and feel there is much we can learn from different countries if we can let go of our dogma and sense of superiority.

ESICM has endeavoured to broaden mobility for intensivists and encourages exchange of ideas throughout which I have always found laudable and would be honoured to participate in.

Clinically, I have always enjoyed teaching and have taken a particular liking to point of care ultrasound. I have found EDEC to be extremely instructive and would like to continue teaching ultrasound and am glad for the extension of training that ESICM is providing. There remain issues with equivalence in the United Kingdom and elsewhere, as well as countries not participating in a structured training pathway and I would like to promote such.
