I am a senior intensive care physician at Stavanger University Hospital. I completed my specialist training in Germany and Norway and have been licensed as a specialist in anaesthesia in both countries since 2017.

In 2019, I successfully completed the advanced training programme in intensive care medicine (SSAI–IC AEP) run by the Scandinavian Society of Anaesthesiology and Intensive Care (SSAI), and I hold SDIC and EDIC diplomas. Since 2024, I have been involved in the ESCIM education programme as an EDIC–2 examiner.

I am currently one of the national coordinators for the Scandinavian Advanced Training Programme in Intensive Care Medicine (SSAI–IC AEP) in Norway. As part of my PhD project, I also collaborate closely with the scientific community at Chalmers University of Technology in Sweden.

As well as these international activities, I am active in national anaesthesiology specialist training. Since 2024, I have been a board member of the Committee for Intensive Care Medicine of the Norwegian Society of Anaesthesiology.

My position on the Norwegian Committee for Intensive Care Medicine and my involvement in the SSAI training programme would enable me to fulfil the duties of a national ESCIM representative, in particular by maintaining contact with national members and the Society for Intensive Care Medicine, promoting ESCIM and recruiting new members.

I would be honoured to represent Norway on the ESCIM Council and contribute to the advancement of intensive care medicine across Europe and internationally.
