Details on your candidature

I have worked in intensive care for thirty years in four countries (New Zealand, Australia, Canada, and the UK) in numerous clinical, academic and research roles – now as a full Professor and Research Division Head at King’s College London. I am an ambassador for the World Federation of Critical Care Nurses, a role that is only bestowed to ICU nurses with an outstanding international reputation, commitment and productivity in the field of intensive care. I am also the deputy lead of the Nurse Professional Advisory Group for the UK Intensive Care Society and the Chair of their Research Division, given my international research profile, the first nurse to ever hold this role. In this role I am currently leading the refresh of the James Lind Alliance Priority Setting Partnership for intensive care research.

My depth of experience makes me an excellent candidate for the NAHP committee. I have an excellent understanding of issues facing intensive care and intensive care nursing from an international perspective. Before completing my PhD and transitioning to a more academic and research focus, I worked clinically for sixteen years in various roles from bedside nurse, senior leadership and senior education roles. This was mostly adult ICU but I also completed paediatric ICU training and worked in PICU in Australia. I have also led ICU nursing postgraduate programmes in Australia and continue to teach mechanical ventilation content in our postgraduate ICU nursing programmes at King’s College London. I also supervise numerous postgraduate (masters and PhD) students of all professions exploring topics relevant to intensive care.

In terms of my international research reputation, I am a researcher ranked in the Top 1% worldwide as an expert on “Critical Care” (ranked at 0.052% of 115,526 published authors), Intensive Care Units (ranked 0.008% of 188,658 published authors) “artificial respiration” (ranked at 0.032% of 116,474 published authors) “ventilator weaning” (ranked at 0.085 of 8,213 published authors) and delirium (ranked 0.087% of 33,433 published authors) (<https://expertscape.com/>). My H-index is 57, and i10 index 142 with ~280 peer reviewed publications and 10,557 citations of my work (Aug 2025). I have numerous international collaborations around the world with excellent and well-renown researchers. I am frequently invited to speak at prestigious critical care conferences

internationally including giving key notes. Therefore, I believe I am of sufficient international standing to perform this role at a level of excellence required by ESICM.
