Associate Professor of Medicine at the Autónoma University of Madrid. Associate Editor of Medicina Intensiva Journal. Recently I have acted as the principal investigator for my center of the SaNDMAN and ALERT-UCI studies and I have led the multicenter study OCEANIA-MS (Opioids Consumption after AdmissioN to Intensive cAre. I am currently applying for the position of National Representative of Spain. For the June 2023 – June 2025 term, I was appointed to both the Executive Committee and the Research Committee of SEMICYUC. During this period, I also served on the Congress Committee, helping organize the 2024 and 2025 National Congresses of SEMICYUC in Barcelona and Valencia, respectively. In addition, I chaired the Working Group on Analgesia, Sedation, and Delirium of SEMICYUC during that same period of time. Through these roles, I gained valuable insight into how a scientific society functions and what the key aspects of its organization are. I also discovered that I greatly enjoy this type of "administrative" work.

I believe that serving as the Spanish Representative on the ESICM Council will allow me to better understand the reality of ESICM and how the society operates. This experience will broaden my perspective and enable me to bring new ideas "back home." I see the role of a National Representative as that of a liaison between my national society (SEMICYUC) and

Europe (ESICM). This connection could foster initiatives ranging from teaching and training to mentorship/fellowship programs and research opportunities. I strongly believe the Intensive Care community should take full advantage of international collaborations, working together to unify not only clinical practice but also education and training. Furthermore, multicenter studies involving diverse geographical areas should become a standard in our field.

Spain has outstanding intensive care specialists, and ICU care is performed at the highest level. However, I believe we still have progress to make in terms of collaboration with our European colleagues. A historical challenge has been related to the English language, and even our younger colleagues often lack confidence in their communication skills. We must empower them, providing a supportive environment where they feel encouraged and heard. As National Representative, I will strive to support and motivate them to take part in a broader, more diverse international community.
